HISTORY

After several years of writing about Australian plants for the popular *Your Garden* magazine Mr A J Swaby founded The Society for Growing Australian Plants in Melbourne in 1957. Regions of the Society were set up in most States with the Hobart Group operating as part of the Victorian Region. The Tasmanian Region was formally set up in 1971 with the Northern Group forming in 1978, the North West Group in 1978 and the Kingborough Group in 1993. In 2014 the Kingborough Group merged with the Hobart Group while retaining their monthly daytime meetings. The name changed to *Australian Plants Society Tasmania Inc.* (APST) in 1999. Each Group is represented by elected representatives at Society Council Meetings and Tasmanian delegates attend meetings of the National Society, ANPSA, and also their conferences, to which all members are invited.

ACTIVITIES AND BENEFITS OF MEMBERSHIP

Group monthly meetings have interesting presentations and may include a display table, plant sales, propagation aids, news from other groups, State and National bodies, a sharing of knowledge from specific species Study Groups, changes in taxonomy, access to APS libraries and the sale of current books at discounted prices.

Activities include propagation at Group Nurseries, flower shows, garden visits, wilderness walks and excursions to areas of botanical interest, all to enable members to gain knowledge and “hands on” experience with Australian plants.

Membership cards are provided to financial members. Discounts are offered by some businesses on the presentation of a Membership Card.

The Tasmanian journal *Eucryphia* is published quarterly and all groups also mail and/or email monthly newsletters. An optional quarterly publication *Australian Plants* is produced by APS (NSW) and is a highly recommended journal providing excellent, beautifully illustrated articles relating to Australian plants in gardens and natural environments around the nation.

Study Groups have been set up nationally to investigate the propagation and cultivation of many families of Australian plants such as Acacia, Banksia, Correa, Dryandra, Eremophila, Eucalyptus including *Angophora*

& *Corymbia*, Grevillea, Hakea, Isopogon & Petrophile and Waratah & Flannel flower. Other Study Groups include Food Plants (Australian), Garden Design, Wallum & Coastal plants and Plants in Pots/Containers.

Regular propagation days are scheduled at Group Nurseries to provide plants for members and for sale at flower shows and other events, and thereby enable members to gain plant knowledge and propagation experience.

Walks and excursions to places of botanical interest varying from gardens to wilderness areas are available to members. These are graded as follows:

A — mostly driving, short walks;

B — more walking, easy paths; and,

C — long walks, uneven ground.

The trip leaders have the right to deny excursion participation to those whose health or fitness is not compatible with the grading of the walk.

Collecting in the field is not APST Inc. policy on official excursions. Permits are required in National Parks etc.
